LCA's main website (WWW.LCAanimal.org) receives over 400,000 hits a month. Social media accounts include FaceBook (over 360,000 followers), Twitter (over 8,900 followers) and Instagram (14,900 followers). LCA's e-mail action alerts ask for "Calls to Action" from members about issues needing urgent attention. Members are e-mailed information and asked to send an e-mail, letter or fax, make a phone call and post on social media to help bring about needed changes for animals.

LCA's founder and president, Chris DeRose, is frequently interviewed for television and radio programs, newspapers and magazines, nationally and internationally. He also travels both in the U.S. and abroad, giving lectures and educating the public about animal rights. Countless people have read or heard about LCA and Chris DeRose through the 20 interviews in 2020.

Locally, LCA and the Animal News Van (ANV), attend special events, conferences, schools and fundraisers. LCA's custom-made, donated ANV is equipped with two large flat screen television screens, a speaker system and LED ticker tape. The ANV uses the powerful medium of video to educate citizens about the current conditions animals live in by showing investigative reports and disseminating breaking news stories. Attendees at each event range from 30-300.

LCA's COVID-19 Campaigns - LCA produced hard hitting educational campaigns, including social media postings, op-eds, e-mail blasts and various media placements about COVID being a zoonotic disease - one that originated with animals and

transferred to humans, making this pandemic the most recent examples of how the consumption, farming and capture of animals can work against humanity.

LCA Stressed the importance of not allowing Agriculture gag (Ag-Gag) laws to be passed in U.S. states and foreign countries that make it illegal to expose animal cruelty, food safety, labor and environmental violations. These violations will go unreported and shielded from public scrutiny, thereby magnifying the risk of zoonotic diseases and more.

Working Towards Stopping the Dog Meat Trade in South Korea - LCA launched S. Korean sister organization, Animal Liberation Wave (ALW), in November 2017 with one mission in mind - to work 24/7 putting an end to the S. Korean dog meat trade that tortures and kills over 1 million dogs annually. Along with global outcry, a strong, public anti-dog meat movement must be mobilized within S. Korea to make real changes at the national level.

During 2020, LCA and ALW put up a billboard featuring Seorak, a dog rescued from a South Korean slaughterhouse, in one of Seoul Metro's busiest stations. The billboard read, "Dogs Loved and Dogs Eaten? No Difference!" and raised awareness that dogs tortured, slaughtered and sold for meat are no different than beloved family pets. Seorak's billboard exposed millions of S. Koreans to the horrible suffering of dogs raised for meat.

Along with Seorak, LCA and ALW delivered an open letter to the Blue House in South Korea urging the government to remove dogs from the "livestock" classification in order to end the dog meat trade. Thirty-seven influential people signed the open

letter, including Kim Basinger, Jane Goodall, and Peter Singer.

In May 2020, LCA and ALW staged a demonstration against the South Korean government's failure to ban the dog meat trade amid the COVID-19 pandemic. The demonstration signaled the start of an international petition demanding South Korean President Moon Jae-in eliminate the dog meat trade. The petition garnered over 65,000 signatures.

A new dog slaughter ban has been introduced in the current 2020-2024 South Korean National Assembly. The bill is an amendment to the Animal Protection Act prohibiting the act of slaughtering and processing of dogs and cats to use or sell for food. The bill states that "the perception that dogs are pets/companions is prevalent around the world" and that "China Taiwan, and others have recently taken measures to phase out dog meat consumption."

Fur-Free Friday and Global Fur Ban - During 2020, LCA joined forces with the Fur Free Alliance, a global coalition of over fifty animal rights groups worldwide, to call for a global ban on fur farming. LCA's petition was launched in December 2020 to garner signatures from people around the world demanding an end to the cruel fur trade. The campaign aims to raise awareness on the link between COVID-19 and mink fur farms and to draw attention to the horrific cruelty animals face on fur farms worldwide.

LCA's 34th Annual Fur Free Friday demonstration was held on November 27, 2020, and attended by dedicated activists who showed up to safely protest during COVID-19. Demonstrators educated the public on the link between COVID-19 and mink fur farms. Protesters stopped outside retailers still selling fur, which included Saks Fifth Avenue, Neiman Marcus, and Dolce & Gabbana, and peacefully urged these companies to go fur-free immediately and not wait until 2023 when the California state fur ban will go into effect.

Fighting Ag-Gag Laws in Canada - During 2020, LCA's legal team was at the forefront of the fight against Ag-Gag Bill 156 introduced in Ontario, Canada in December 2019. LCA testified before the Ontario Legislature about the importance of whistleblowing in animal agriculture and the dangers of Bill 156. LCA also proved that transparency in agriculture to Ontarians through a poll of Ontarians and presented the results of the poll to the government. The poll appeared in over fifty media outlets across Canada. LCA's op-ed by legal counsel on the importance of transparency in animal agriculture received so much coverage in the Canadian media that the Ontario Minister of Agriculture responded with his own op-ed. LCA held a joint press conference with other animal groups and presented footage of conditions discovered through undercover investigations into animal agriculture, to show Ontarians why ag-gag bills are dangerous.

There are only approximately 1,000 mountain gorillas left in the world. They are in the Virunga Volcanoes Massif mountain range in Uganda, Rwanda and the Congo, and in Bwindi Impenetrable Forest in Uganda. In 2016, LCA's campaign turned to supporting

the AirWing program of war-torn Virunga National Park in the Congo, where rangers risk their lives daily to protect the land, the natural resources, the wildlife and the majestic mountain gorilla from poachers and rebel militia. In addition, the economic fallout from COVID-19 in the Democratic Republic of the Congo is causing another deadly surge, in bush meat poaching. There's been a giant spike in the number of poacher's snares set to slaughter unsuspecting gorillas for bush meat.

Since the park opened in 1925, over two hundred Virunga rangers have lost their lives in the line of duty protecting the park and the wildlife. In April 2020, LCA President Chris DeRose condemned the senseless attack of violence by rebel militia that left seventeen people dead, including 12 Virunga Rangers, their driver, and three civilians. Three rangers survived the attack. Virunga Park's AirWing used LCA donated planes to medivac the injured and transport the fallen Rangers and driver back home to their families.

A functional and modern AirWing program provides the best possible tool to secure the park and reduce threats to Virunga's rangers and wildlife population.

In 2016, LCA provided the AirWing with airplane bush wheels, mobile LED airstrip lighting and tool chests. In April 2017, LCA's donated Cessna 206 aircraft arrived in Virunga National Park after a journey of 8,600 miles from Colorado to Virunga. Shortly after the plane arrived, it was used to transfer twenty-four rangers rapidly to a site in the park that was under serious threat of militia attack. There is no doubt the aircraft had a key role in the attack being averted and numerous animals and rangers' lives were saved. The plane will provide lifesaving assistance to the rangers in protecting the land and the wildlife at Virunga - including the majestic

mountain gorillas. In October 2017, LCA was able to support Virunga in purchasing the land their airfield is located on, now called Katale-LCA Airfield. This is a major turning point for Virunga's AirWing, as previously they were forced to rent the airfield near their headquarters and faced constant threats of being evicted, which would have brought the AirWing program to a screeching halt, affecting the conservation of the park and its animals dramatically. In 2018, LCA provided a Bat Hawk Light Sport Aircraft to Virunga's Airwing and electric fencing to fortify the airfield and protect the Airwing. In 2019, LCA provided funding to fortify Katale-LCA airfield with 2-meter-high Bastion walls and for construction of a hangar to house the AirWing's air fleet and housing for twelve rangers. In 2020, LCA provided ongoing support to the AirWing, rebuild of a Cessna 206 engine and provided a second Bat Hawk Light Sport Aircraft to the AirWing's growing fleet.

The SIU team focuses on validating information, detecting suspect activity, exposing illegal or unethical activities and reporting them to local, state and federal authorities for prosecution. The information obtained in LCA's investigations is used to develop campaigns, provide grassroots education and outreach to the public, and to help in drafting legislation that will bring lasting changes for the animals. The scope of LCA's investigations includes, but is not limited to: pet theft, class "B" dealers, puppy mills, Asian dog meat trade, pound seizure, circus cruelty, elephants in captivity, animals used in entertainment, vivisection and pharmaceuticals manufactured from the demise of animals.

Charges against Millbank delayed due to COVID-19 - LCA's Undercover Investigation of Millbank Fur Farm Leads to 14 Counts of Animal Cruelty - LCA's investigation of Millbank Fur Farm was the first time an undercover investigation in Ontario, Canada led to charges. LCA exposed disturbing accounts of animal neglect and suffering amongst the 40,000 mink that live, and die, at the farm annually. This investigation is the first in-depth undercover probe of a fur farm that produces pelts for the Canadian fur industry, which kills more than three million animals for fur each year.

Over the course of a year, LCA's undercover investigator documented horrific cruelty and gathered evidence revealing rough handling of animals, unsanitary conditions, sick animals living with open, untreated wounds and infections, lack of food and unsanitary shelters. During the investigation, LCA's investigator never saw a veterinarian on site.

LCA submitted all evidence collected in a complaint to the Ontario Society for the Prevention of Cruelty to Animals (OSCPA). In February 2018, the OSCP launched their own investigation into the farm and 3 months later, in May, charged Millbank Fur Farm with fourteen counts of animal cruelty, stating, "No one is exempt from the law."

At a court hearing in June 2019, a plea bargain was not reached, and the Crown continued to move forward on all charges. The Millbank case remains active and before the Provincial court in Guelph, Ontario. COVID-19 has delayed the matter due to court closures. The case is expected to proceed to trial in early 2021.
